COLLECTIONS CORNER

The 2014 Spring/Summer months are here! That means the collection crew is busy starting its yearly projects. Here are some things that we will be working on this season:

- Replacement of 350' of sewer pipe on McLellan St. which includes 2 new sewer manholes.
- Replacement of 500' of sewer pipe on Whittier St.
- Replacement of broken sewer wyes on Patricia St, in preparation of town paving.
- 54,000+ feet of sewer line will be cleaned by our Jet-Vac truck.
- Pipe lining bad sections of sewer pipe.
- Continued video inspection of sewer pipe to look for any problems.
- Continued upkeep in and out of all pump stations and grounds.

When you see our trucks out on the street, be sure to give a little wave.



TREATMENT PLANT UPGRADE UPDATE

The project design contract has been awarded to Wright-Pierce of Topsham. Their proposed design and construction schedule is as follows:

DESIGN PHASE

Preliminary Design:

June 2014 - Sept 2014

Final Design:

Oct. 2014 - May 2015

BSD/MDEP Review & Approval:

June 2015 - July 2015

Bidding Phase:

Aug. 2015 - Oct. 2015

Construction Phase:

Nov. 2015 - Nov. 2017

While the engineers are working on the design this year, staff will be focusing on the funding side. We will be asking our Board of Trustees to approve the filing of the application to the Maine Municipal Bond Bank for a State Revolving Fund loan (SRF) through the Maine Department of Environmental Protection. The SRF loan is typically 2% below the prime lending rate. The Board will need to adopt a bond resolution and then schedule a public hearing on the bond. Following the public hearing we will begin the formal process for the loan.

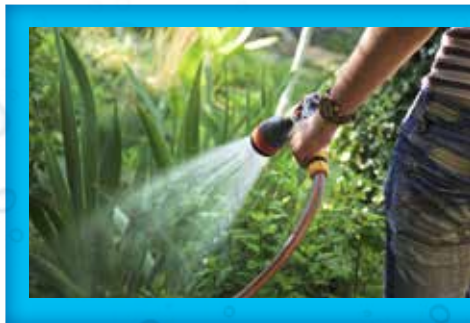
While the first payment on the bond will not be due until late 2017 or early 2018 we will need to increase the sewer rate incrementally over the course of the next few years to have the funds available for the projected \$1.2 to \$1.4 million annual payment. We estimate that the average household annual charge will go from the current \$375/year (\$32/month) to \$530/year (\$44/month).

- At any time of the year when you may be using water that does not enter the sewer system – such as watering lawns or gardens, filling swimming pools or flooding ice rinks - you may be eligible for an outside water use adjustment. Please call 729-0148 ext 110 to verify your credit. Remember you must call us each quarter to receive your credit adjustment.
- Before your contractor digs, remember to call Dig Safe (1-888-344-7233). It's free and it's the law.
- When experiencing a sewer system problem, please contact the District first. The 24-hour emergency pager is 580-3175.
