RATE SCHEDULE A - **METERED USE:** The sewer use rate <u>for property deriving its main supply of potable water from a <u>METERED source</u> will be based on water meter readings for the property. The minimum charge per quarter for sewer service to such property will be \$ **42.40** for the first **500** cubic feet metered, and \$ **8.48** for each 100 cubic feet metered thereafter.</u>

<u>RATE SCHEDULE B</u> - FLAT RATE FIXTURES: The quarterly sewer use charge <u>for property deriving its potable water from an *UN-METERED* <u>source</u> will be based on the following schedule of fixture unit rates.</u>

RATE SCHEDULE C - SERVICE CHARGE: A Service Charge of \$6.00 per quarter will be charged to each account.

RATE SCHEDULE D - **ROOF DRAINS:** The sewer use rate for property having an exisiting roof drain(s) discharging to District sewers will be **\$84.80** per 1,000 square feet of gross roof area or portion thereof per quarter. For roof area in excess of 1,000 square feet, sewer use will be charged at the rate of **\$8.48** per 100 square feet or portion thereof per quarter.

RATE SCHEDULE E - CATCH BASINS: The sewer use rate for catch basins discharging to District sewers will be \$480.82 per catch basin per quarter.

RATE SCHEDULE F - **SEPTIC TANK AND HOLDING TANK WASTES:** The facility use rate for discharge of septic tank waste to District facilities will be **\$135.00** per 1,000 gallons discharged. The facility use rate for discharge of holding tank waste to District facilities will be **\$70.00** per 1,000 gallons discharged. A minimum charge of **\$20.00** shall apply.

RATE SCHEDULE G - TSS & BOD LIMIT: The sewer use surcharge rates, to be added to the normal user charges, for discharge to District sewers for which the average concentration exceeds the TSS and BOD limits as set forth in the District User Rules and Regulations shall be as follows.

Total Suspended Solids (TSS) \$1.30 per pound (lb)
Biochemical Oxygen Demand (BOD) \$1.27 per pound (lb)
